Copyright Sharing Agreement

This Copyright Sharing Agreement (the "Agreement") is made and entered for collaborative publishing, by and between [Party A] ("Licensor" as Author) and [Party B] ("Licensee" as DaKES).

Recitals

WHEREAS, Licensor is the owner of certain copyrighted works (the "Works") described in Exhibit A attached hereto;

WHEREAS, Licensee desires to obtain a non-exclusive license to use, reproduce, distribute, and publicly display the Works; and

WHEREAS, Licensor is willing to grant such a license to Licensee, subject to the terms and conditions set forth in this Agreement.

NOW, THEREFORE, in consideration of the mutual promises, covenants, and conditions contained herein, the parties agree as follows:

1. License Grant

Subject to the terms and conditions of this Agreement, Licensor hereby grants Licensee a non-exclusive, royalty-free, worldwide license to use, reproduce, distribute, and publicly display the Works for the purposes specified in Exhibit A. Both parties share 50% of the profits, with free publishing.

2. Attribution

Licensee shall provide appropriate attribution to Licensor in connection with any use of the Works.

3. Term and Termination

This Agreement shall commence on the Effective Date and shall continue in long term unless terminated by either party upon thirty (30) days' written notice to the other party.

4. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the USA. English and Chinese are equal effectiveness.

5. Entire Agreement

This Agreement constitutes the entire understanding between the parties with respect to the subject matter hereof and supersedes all prior and contemporaneous agreements, representations, and understandings, whether oral or written.
